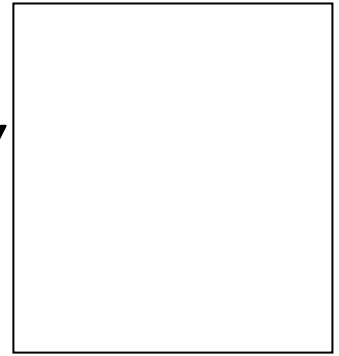
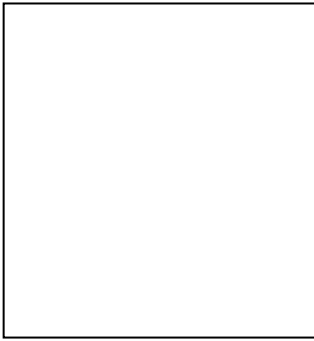

BETWEEN

FOOTPRINTS OF DAVID ART a nonprofit making organization registered under C.A.C as an ART ENTERPRISE with the head office at 8 Arobadade street Ilaje Bariga (hereinafter referred to as FODAA which expression shall where the context so to admit its assigns and successor-in-title) of the first part.

AND

..... A training dance/drama/music instructor or a performance artist in Nigeria of Nigeria (hereinafter referred to as "the trainee" which expression shall where the context so admit its assigns and successor-in-title) of the second part.

WHEREAS

1. FODAA is involve in the business of cultural preservations and exchange/performance art education/performing art/artiste management/props & costume rentals/ children theatre consultancy/Art consultancy and general merchandise.
2. The trainee is an aspiring performing artiste/dance/drama/music instructor in Nigeria and beyond.
3. FODAA has agreed to train both paying and non paying training individual/organization
4. The parties agree to adhere strictly to the terms as contained in the policies as provided for in the schedule to this memorandum of understanding and ALSO importantly the verbal/oral ones.

IT IS AGREED as follows:

THAT in consideration of the observance of the various covenant stipulated hereunder the parties undertake to use their best endeavors to ensure the said paying and non paying individual and or organization are provided with the best service in the world class standard

FODAA CONVENANTS as follows;

1. To pay the trainee 10% (ten percent) of the gross payments made by the paying individual or organization for either dance/drama/poetry/advertisement/films/music/ projects they took part in or assist as an instructor/facilitator in Nigeria and beyond.
2. To provide dance related materials to the trainee as required

THE TRAINING CONVENANTS as follows

1. To pay a sum of N80, 000 (EIGHTY THOUSAND NAIRA) for their training fee except they got a scholarship discount of 30-50% (percent) off.
2. To attend a minimum of 80% (percent) of the training classes/rehearsals as stipulated by FODAA and to undergo appraisals every 3months
3. To source for a minimum of one individual donor for FODAF (Footprints of David Art Festival) by FODAA every 28th-30th December
4. To help with administrative assignment/errands whenever they are needed
